This bid for this project that includes the new downtown streetlighting, installation of electrical cables underground, and brick ribbon at the back of the curb was approved by the City Council in November of 2023. A contract has now been drafted and signed by the Contractor for work to begin.

8. AUTHORIZE THE MAYOR TO EXECUTE A SUPPLEMENTAL MEMORANDUM OF AGREEMENT WITH THE COUNTY OF DEKALB FOR DISPATCH SERVICES


The City of Genoa contracts with the DeKalb County Sheriff's Office for 911 dispatching services and has done so since 2003. Through ongoing conversations with DeKalb County regarding dispatching services, the DeKalb County Sheriff's Office has taken cost savings measures to reduce costs in their 911 communications operations and are therefore reflecting the costs savings within the dispatching costs owed by each community. This cost savings is due to combining both Sycamore and Genoa on one dispatching channel with the remainder of the County for twenty-four hours a day instead of twelve, reducing staffing demands. DeKalb County Sheriff's Office has offered several cost reductions over the past 5 years. For perspective, under this contract, the City will pay \$110,000 in 2024-2025, which is the lowest it has been since 2003. Under the terms of the current agreement, the City's fees were to increase to \$131,000 in FY 2024-2025.

THE CITY OF GENOA, DEKALB
COUNTY, ILLINOIS

The Fiscal Year 2025 budget includes total City Revenues expected to be \$11,849,980, and total Expenditures expected to be \$14,134,000. Expenditures are



higher than revenues due to almost \$8,000,000 in Capital Purchases and Projects that are scheduled to be completed in FY2024-2025, including, Streets, Sidewalks, Downtown Revitalization, Lead Service Line Replacements, Water/Sewer Infrastructure Improvements and Equipment Purchases.

Priorities between budget years of operations remain largely the same with an emphasis on Capital for streets, water and sewer infrastructure, and a large Downtown Revitalization project. Highlights of the 2024-2025 budget include an overall balanced General Fund budget with an increase of 3.5% in revenues and a 4.5% increase in expenditures since the FY 2023-2024 budget, and almost \$8,000,000 in Capital expenditures.

FY2024-2025 Budget Highlights:

- MFT Rebuild IL Street Project \$342,420
- Over \$525,000 in Street and Sidewalk repairs
- Water Distribution System Improvements \$560,000
- \$4 Million Lead Service Line Replacement Program in Partnership with the IEPA Low Interest Loan and Forgiveness (if awarded)
- \$1.5 Million Downtown Revitalization Project
- Police Department Equipment -E Force Software System and UTV \$75,000
- Public Works Department Equipment- Dump Truck / Plow and mower \$313,000
- Public Works Department Equipment Ford Explorer \$40,000

B. DISCUSS INSTALLING EARTHCAM IN THE DOWNTOWN

In the packet is a quote for the installation of a camera for the downtown that would provide a live stream to eartcham.com. Many cities and organizations provide a live camera as a way to promote their events, tourism, or cause. The cost of the camera is outlined in the quote as well as the yearly hosting fee for the live feed. A downtown business owner has agreed to allow the camera to be affixed to their building. The expected installation by a contractor is \$1,500.
