## ORDINANCE NO. 2024-16 AN ORDINANCE AMENDING TITLE 6, CHAPTER 2, STOPPING, STANDING AND PARKING, SECTION 8 OF THE MUNICIPAL CODE OF THE CITY OF GENOA

WHEREAS, the parking of cars on streets off of Forest Lane has become a concern of residents in the area; and

WHEREAS, parking on these streets may block emergency infrastructure or access;

WHEREAS, parking lots have been installed in Unit 4 of the Riverbend subdivision;

NOW THEREFORE, BE IT ORDAINED the Municipal Code of the City of Genoa be amended as follows:

SECTION 1: That Title 6, Chapter 2, Stopping, Standing and Parking, Section 8, be amended to add:

## 6-2-8: PARKING PROHIBITED ON CERTAIN STREETS:

Parking of vehicles is prohibited at the following places, on the following streets, and said locations listed herein may be amended from time to time. There shall be no parking at any time on:
